Foodbank - Catholic Charities serves the hungry through emergency food assistance in Clark, Champaign and Logan Counties. Last year, 134,055 people received emergency assistance from the Catholic Charities food bank and food pantries. Second Harvest Food Bank distributed 4,964,749 meals through 91 member agencies.

Mental Health Services - Catholic Charities provides a wide range of affordable, confidential counseling services. Counseling equips people with the skills to grow psychologically and spiritually. Counselors connect clients with life skills to use as need to cope and succeed. In late 2015 and early 2016, Catholic Charities began the process to expand services and became certified to provide community psychiatric supportive treatment (CPST). In 2015, the Mental Health Services served 5,467 people through individual, couple and family counseling. 30% increase in mental health sessions in 2015 due to rapid expansion into Hamilton and Fairfield School Districts and greater capacity.

Refugee Resettlement
Imagine arriving in Cincinnati after living decades in a refugee camp with little freedom. Everything is foreign from the street signs to the electric lights that turn on with a flip of the switch. Running water is a convenience that astonishes many. Refugees come with little more than clothes on their backs and hearts full of hope for a better life for their families.
Through your support, Catholic Charities resettled 228 refugees (families, elderly and children) with housing last year. 74% came from Asia, largely Bhutan, and 18% came from Africa. The refugees receive job training and 91 secured employment.
